The Vigil Honor is the Highest Honor that the Order of the Arrow can bestow upon its members for SERVICE to their lodge and to their council. It dates back to the year 1915, when its founder E. Urner Goodman, became the first Vigil Honor Member. It is a mark of distinction and recognition reserved for those scouting members in the order who, by reason of exceptional service, personal effort, and unselfish interest, have made distinguished contributions beyond the immediate responsibilities of their position or office to one or more of the following: their lodge, The Order of the Arrow, Scouting, or their Scout Camp.

ANY Witauchsoman Lodge member may nominate any other member provided the nominee has been a brotherhood member for at least two years, is registered in scouting and has their lodge dues paid. The nomination is made by completing this form and sending it to the Vigil Honor Committee Chairman or to the Council Service Center. This nomination should include examples of the nominee's outstanding service. Remember... "For, said he, who serves his fellow is of all his fellows, greatest!" - *Meteu*

The filing of this form does not in any way guarantee that the nominee will receive the Vigil honor. Election for the Vigil Honor and final approval rests with the lodge and with the National Vigil Honor Committee.
